 - i. Went smoothly on their end
 - ii. Issues with judging for smaller bands
 - iii. Scott Lambert encouraging directors to participate
 - 1. Panel to review adjudication at state-wide assessments for marching
 - 2. Decided to hire assistant marching band chair
 - 3. Initiating adjudication-training program
 - 4. Site host and site coordinator (who is supposed to read a script, with info about a rubric)
 - 5. Disparity with adjudication of varying styles
