b) Marching Assessment Event, West Site; Bruce Miller

Emory and Henry ran the marching assessment event for marching assessment. The organization went well this year.

c) All-District Auditions; Mark Collins, Josh Turner

Mark Collins reported that the all district audition went well with around 780 students auditions (including doubles). Numbers are up slightly over the past

year and more schools are participating. The platform created by Logan Childress continues to work well. Thank you for your continued patients with tabulations.

d) **All-District Event**; Michael Farina, Joe McNulty, Erica Coates Michael Farina thanked everyone for the event running smoothly. Please get checks to him if you have not done so already. Thank you to directors that volunteered percussion equipment. Medals are on the VBODA website. You are responsible for ordering medals for your students. They are \$4.50 each. Certificates were printed and distributed. Please check them for inaccuracies. They can be fixed here at the event, otherwise you will have to fix them on your own. If you are not watching the concert tomorrow, we will be breaking percussion rooms down as we go. Please participate in the loading out of equipment.

Next year, we will require a new district event chair. In the future, we need to work cooperatively for this event. We need more donations of percussion equipment and create a rotating list to help spread the work around the district.
